



## WEBSITE TERMS OF USE

### 1 **Terms of use**

### 2 **Other applicable terms**

2.1 These Terms of Use refer to the additional terms in our Website Privacy Policy, which also apply to your use of our Services.

2.2 Our Website Privacy Policy sets out the terms on which we process any personal data we collect from you, or that you provide to us. By using our Services, you consent to such processing and you warrant that all data provided by you is accurate. We also retain the right to create limits on use and storage at our sole discretion at any time and without prior notice to you.

## 6 **Accessing our services**

6.1 Our Services are made available free of charge.

16 **Several users**

If there are two or more persons adhering to these Terms of Use as user, their liability under the Terms of Use is joint and several, and their rights are joint.

17 **Waiver**

No failure or delay by a party to exercise any right or remedy provided under this agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

18 **Termination**

18.1 The Terms of Use will continue to apply until terminated by either you or us as follows.

18.2 You may end your agreement with us at any time for any reason by discontinuing your use of the Services. You do not need to specifically inform us when you stop using the Services.

In case of discrepancies between the English and Chinese language versions of these Terms of Use and contents of this site, the English version shall prevail.
